1. This Order shall take effect from and immediately after this thirty-first day of January, one thousand eight hundred and seventy-seven; and words in this Order have the same meaning as in the Act of 1869.

2. This Order may be cited as The Metropolitan

Cattle Plague Order of 1877.

3. This Order relates to the Metropolis only; and the provisions thereof are supplemental to and not in substitution of those of The Animals Order of 1875.

4. No cattle, sheep, or goats shall be moved out of the Metropolis.
