ART. 11. The "Visitador" will send in his report of each steamer separately, with all the documents, &c. In the cases coming under Art. 30, he must

report to the Captain of the Port.

Ant. 12. When the entries are made in the Immigration Register the Commissary-General will return the passports or other documents, marking on them the date of arrival and other particulars, but retaining those belonging to persons whom he may suspect of having availed themselves of the Immigration Law, not to settle in this country, but to get cheaply to reighbouring countries, such as Banda Oriental, Brazil, or Paraguay; he will also keep the passports of all immigrants who may ask him to do so for safe custody, in which case it will be entered in the register.

ART. 13. Any captain or member of the crew of immigrant steamers who shall deceive the immigrants as to the scope of the Immigration Law, their civil status in the country, or try to inspire them with a want of confidence in the disembarkation law, &c., will be subject, on the evidence of three persons, to a fine of 500 hard dollars, and to pay part of the expenses which those so

deceived may have been put to.

ART. 14. All who infringe this present law, or promote disorder while it is being carried out, shall be punished as follows:

A fine of 50 to 100 hard dollars if the delinquent be the captain of the steamer or one of his crew.

A fine of 30 to 50 hard dollars if the delinquent

be skipper or sailor of any port craft.

If any of the passengers or private persons so offend, the fine shall be from 10 to 20 dollars; in these three categories, the steamer and its belongings, the port craft, and the luggage or any trinket of the passengers shall be held accountable for the fine. If the offence occurs on board, and comes under the 2nd or 3rd category, and the delinquent is insolvent, he shall be imprisoned from 10 to 15 days on board the Ponton, where he must give personal service.

ART. 15. The Commissary General has summary jurisdiction in imposing and collecting all

fines under this law.

ART. 16. On the Commissary General calling on the public forces for assistance, the Capitania, the Resguardo and the nearest national war vessel in the roads are bound to render it at once.

And in the cases which come under Art. 37 the

Capitania shall proceed in the same manner.

ART. 17. In cases of fine the decisions of the Commissary can be appealed from to the Minister of the Interior, provided the fine be first paid, and

the Minister's decision shall be final.

ART. 18. It is the duty of the Commissary General of Immigration to supply all captains of steamers with two copies of the Immigration Law and at least five of the Regulations; this he can do either in Europe, through the Argentine Consuls, or here when the steamer arrives, without charge, but the Captain must give a receipt. The regulations must be posted up in the most conspicuous art of the steamer, in a frame, in Spanish, French, English, Italian, and German.

ART. 19. The Commissioners of Immigration and Maritime or riparine officials in all parts must enforce these Regulations and report to the Com-

missary General.
