2. I am to request that you will inform the Commander-in-Chief that the Governor-General in Council entirely concurs with his Excellency as to the excellence of the arrangements made for the defence of his position by Colonel Jenkins, and the ability, promptitude, and judgment in attack displayed by Brigadier-General Macpherson.

3. The Governor-General, I am to state, shares with Sir Frederick Haines his admiration of the gallantry and steadiness evinced by the troops on

this as on all other occasions.

## KABUL.

No. 2327-A., dated Simla, 25th May, 1880. From Major-General G. R. Greaves, C.B., Adjutant-General in India, to the Secretary to the Government of India, Military Department.

I HAVE the honour, by direction of the Commander-in-Chief, to forward, for submission to Government, the accompanying reports describing the operations of the troops under the command of Brigadier-General H. T. Macpherson, C.B., V.C., and Colonel F. H. Jenkins, C.B., at Chara-

siah, on the 25th April, 1880.

2. His Excellency concurs with Sir Frederick Roberts as to the excellent arrangements made for the defence of his position by Colonel Jenkins, and as to the ability, judgment, and promptitude in attack displayed by Brigadier-General Macpherson, and begs to bring these officers' services on this occasion prominently to the notice of Government.

3. It is further a source of great gratification to Sir Frederick Haines to refer to the gallantry and

steadiness shown by the troops engaged.

4. The usual nominal returns of casualties have been called for; and these, with the sketches referred to in the Despatches, which are being lithographed, will be forwarded hereafter.

Field Operations. No. 1815, dated Camp Zahidabad, Logar Vulley, 11th May, 1880. From Lieutenant-General Sir F. S. Roberts,

K.C.B., V.C., C.I.E, Commanding the Kabul

Field Force, to the Adjutant-General in India. I HAVE much pleasure in submitting, for the information of His Excellency the Commanderin-Chief, the accompanying reports from Brigadier-General H. T. Macpherson, C.B., V.C., and from Colonel Jenkins, C.B., A.D.C. to the Queen, commanding the Corps of Guides, descriptive of their operations at Charasiah on the 25th of April last.

2. I beg to bring to His Excellency's notice the excellent arrangement made by Colonel Jenkins for the defence of his position when he found the enemy's number increasing, and the success which attended his efforts to preserve the baggage animals

from the long-range fire of the enemy.

3. The dispositions made by Brigadier-General Macpherson, C.B., V.C., display skill and judgment, and the promptitude with which that officer attacked, and in conjunction with the troops under Colonel Jenkins, C.B., drove off the enemy with heavy loss to them, deserves my cordial acknowledgments. It affords me great pleasure to bring the valuable services of Brigadier-General Macpherson and Colonel Jenkins to His Excellency's most favourable notice.

4. I would also remark on the gallantry and Roberts, K.C.B., V.C., commanding the Kabul No. 24869

steadiness of the troops engaged, and on the excellent spirit they displayed during a long and

exhausting day.

5. The doubtful attitude of the Kohistanis made it impossible for me to detach permanently from Kabul a force of any considerable strength; but as Charasiah could be easily reached from Kabul, and as speedy communication by means of the heliograph could be kept up with Colonel Jenkins, I considered that his force was amply sufficient to hold its own in case of attack until reinforcements could be despatched, and in this decision I was borne out by the circumstances

that actually occurred. 6. Had I arrived sooner on the ground after the termination of the engagement, I should have made the troops bivouac there for the night; but finding, as I did soon after leaving Sherpur, that Brigadier-General Macpherson had ordered the tents and baggage of Colonel Jenkins' force back to Sherpur, and knowing that the troops had had a severe day, I considered it expedient to allow them to return. Moreover, the enemy never ceased their flight until they had reached the further end of the Logar Valley; and the decisive character of their defeat, prevented, therefore, any impression which otherwise might have arisen that our withdrawal to Sherpur was in any way compulsory.
