every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. Each of the areas described in the Schedule to this Order is hereby declared to be an area infected with foot and-mouth disease.

2. This Order shall take effect from and immediately after the 3rd day of October, one thousand eight hundred and eighty-one.

Contagious Diseases (Animals) Act, 1878, and of | of a Despatch from Her Majesty's Vice-Consul at Cairo, enclosing a copy of the Regulations issued by the Egyptian Maritime and Quarantine Council in consequence of the outbreak of cholera at Aden, of which the following is a translation, viz. :-

EGYPŢIAN SANITARY, MARITIME, AND QUARANTINE COUNCIL.

Sitting of 7th September, 1881.

In consequence of the outbreak of cholera at Aden, the Council have decided that :-

I. All vessels arriving from Aden and from Ottoman Ports in the Red Sea, although furnished with clean bills of health, and on board of which no cholera cases or suspected cases have appeared, must be put into quarantine for a period of 7 clear days dating from the medical in-pection.

This quarantine to be kept at "The Wells of Moses.

If, however, the Sanitary Authorities are satisfied, after a thorough inspection, that there have been no cases of sickness of any description whatever during the voyage, and if the vessels are besides in a thoroughly good condition as regards health, the length of the quarantine may be diminished in the following scale :-

After 8 days' voyage, 6 days' quarantine. After 9 days' voyage, 5 days' quarantine.

After 10 days' voyage, 4 days' quarantine. After 11 days' voyage, 3 days' quarantine. After 12 days' voyage, 2 days' quarantine.

A vessel, after a voyage of more than 13 days, will be only required to perform 24 hours' quarantine

The ship, before going out of quarantine, shall be disinfected.

All persons who may be on board will not be considered free from the quarantine regulations until the ship and also their wearing apparel has been disinfected.

As long as no case of cholera has shown itself, the "observation quarantine" may be performed by passengers on board, in default of a lazaretto, that is, if the hygienic conditions of the ship permit it, otherwise the vessel must be to sent to Tor to perform strict quarantine.

Any susceptible goods (that is, those which might be capable of being infected and transmitting the discase), must be landed at "The Wells of Moses," and disinfected before being sent to the consignees. No limit of time is fixed for these operations.

Those goods which would not be included in the above category will be immediately landed and delivered to the consignees, only however if there has been no suspected case of sickness on board ; this operation will be effected in quarantine under the superintendence of the Sanitary Authorities.

The discharge of non-susceptible goods and the shipment of goods of all description may be effected wherever there may be a Sanitary Agent. The shipment and discharge must be effected with all precautions and under the superintendence of the Sanitary Authorities.

2. Every infected ship, that is, every vessel on board of which any certain or only probable cases of cholera have occurred during the transit, no matter of what duration the voyage, or even discovered on the arrival of the ship, must be put into strict quarantine. This quarantine to be for seven clear days for persons, dating from their isolation in the lazaretto; in certain exceptional cases the time may be increased to ten days, according to the decision of the Sanitary, Maritime, and Quarantine Council.
