Production of Licences; Names and Addresses 24.—(1.) Every person in charge of animals being moved, where, under this Order, or under any Regulation of a Local Authority under this Order, a Movement Licence is necessary, shall, on demand of a Justice, or of a Constable, or of an Inspector or other officer of a Local Authority, produce and show to him the Movement Licence, if any, authorizing the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Every person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or Constable, or Inspector or other officer.

(3.) If a person in charge of animals being moved, where, under this Order, or under a Regulation made by a Local Authority under the provisions of this Order, a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1878.
