Any Lady who proposes to be presented must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve o'clock*, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulations, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that an intimation from the Lady who is to make the presentation, of her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them.

It is not expected that Gentlemen will present themselves at the Drawing Room, except in attendance on the Ladies of their families.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve o'clock*, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

(SWINE-FEVER.)

AT the *Council Chamber, Whitehall*, the 16th day of *April, 1886*.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—so much of the borough of Barrow-in-Furness as lies within the following boundaries, that is to say, from a point on the north-east side of Hindpool-road at its junction with Cornwallis-street and on the north-west side of Cornwallis-street, thence crossing Hindpool-road down the centre of the road to the main line of the Furness Railway Company, thence on the north-east side of the said line in a north-easterly direction to the Bridge crossing North-road, thence following the south-east side of but excluding the said road in a north-easterly direction to its junction with Hindpool-road, thence following the south side of but excluding Hindpool-road to a point opposite the Custom House, thence across Hindpool-road to the Custom House, and thence on the north side of the said road to the starting point,—which was declared by Order of Council dated the first day of March, one thousand eight hundred and eighty-six, to be an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the seventeenth day of April, one thousand eight hundred and eighty-six.

1886. Ordinance of Maritime Health, No. 6.

The Minister of the Interior, having officially ascertained that the cholera has entirely ceased in Spain, excepting only at Tarifa, where a few isolated cases occur, decrees:—

The dispositions sanctioned by Ordinance No. 5 of 22nd March last for the revocation of quarantine on ships coming from Spanish Mediterranean ports, shall from this date be applied to vessels arriving from any other Spanish port with the sole exception of Tarifa and its vicinity, for which remain in force the quarantine regulations made by Ordinance, No. 6 of 1st August, 1885.

SCHEME of the Local Government Board under the Municipal Corporations Act, 1883:—

Usk.

Local Government District of Usk.

To the Portreeve and Burgesses of Usk, in the County of Monmouth;—

To the Usk Local Board, being the Sanitary Authority for the Urban Sanitary District of Usk, in the said County;—

And to all others whom it may concern.

WHEREAS by Section 3 of the Municipal Corporations Act, 1883, it is enacted that on and after the 25th day of March, 1886, or such later day not after the 29th day of September, 1886, as Her Majesty in Council may in the case of any place or places appoint, the following provisions shall apply to each of the places mentioned in the Schedules to that Act to which Her Majesty may not be pleased before the said day to grant a new Charter; that is to say:—

“(a.) The place shall not be a corporate town or borough, and any municipal or other corporation thereof existing under any charter or grant or prescription shall be dissolved;”

“(b.) All property of any corporation in the

place which is dissolved by this Act, or of any person as member or officer thereof, or of any court or judge whose jurisdiction is abolished by this Act, shall be applied for the public benefit of the inhabitants of the place in such manner as may be for the time being provided by a Scheme of the Charity Commissioners, or, in a case where a Scheme is made by the Local Government Board, by that Scheme, and shall vest in such persons or body corporate as may be specified in such Scheme.”

And whereas by Section 7 of the said Act, it is enacted as follows:—

“Where any part of any of the places mentioned in any of the Schedules to this Act is comprised in the District of any Local Board or Improvement Commissioners whether established before or after the passing of this Act, and Her Majesty is not pleased to grant a Charter to such place, the Local Government Board, after such local inquiry as they think expedient, may, at any time before any Corporation in the said place becomes abolished by this Act, make such Scheme as might be made by the Committee of Council under Part Eleven of the Municipal Corporations Act, 1882.”

And whereas Usk is a place named in the First Schedule to the Municipal Corporations Act, 1883, and it is not intended to petition Her Majesty for the grant of a Charter of Incorporation for such place; and by an Order in Council of the 17th day of February, 1886, the 29th day of September, 1886, has been appointed as the day on and after which the first above-recited provisions shall apply to the said place;

And whereas the said place is conterminous with the District of the Local Board of Usk, and the said Local Board of Usk are herein-after referred to as “the Local Board”;

And whereas the said Portreeve and Burgesses of Usk are a body corporate under and by virtue of a grant or charter or prescription, and are in this Order referred to as “the Corporation”;

And whereas it is expedient that a Scheme for the adjustment of the powers, rights, privileges, franchises, duties, property, and liabilities of the Corporation should be made as hereinafter provided:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows:—

ARTICLE I.—This Scheme shall come into operation on the twenty-ninth day of September, one thousand eight hundred and eighty-six. Such date is herein referred to as the “commencement of this Scheme.”

ARTICLE II.—From and after the commencement of this Scheme all the property, real and personal, possessed by or vested in the Corporation or any person or body in trust for it, or any of its members as such, or applicable for the benefit or under the direction of the Corporation, or any of its members as such, shall be vested in the Local Board.

ARTICLE III.—The Public Health Act, 1875, shall apply to property vested by this Scheme in the Local Board as if such property had been acquired by the Local Board under that Act; and the receipts and expenditure of the Local Board under this Scheme shall for all purposes be deemed to be receipts and expenditure under that Act.

Provided that the income derived from the said property shall be applied so far as possible in paving and improving the paths and footways in the District of the Local Board, or otherwise for the improvement of the said District.

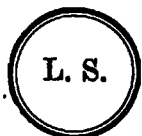
Provided also, that the Local Board shall not, without Our consent, sell or exchange any property vested in them under this Scheme.

ARTICLE IV.—All liabilities which immediately before the commencement of this Scheme attached to and were enforceable against the Corporation or the property thereof, shall attach to and be enforceable against the Local Board so far only as the property vested in the Local Board by this Scheme may extend to satisfy such liabilities, and no further.

ARTICLE V.—Any investigation, legal proceedings, or remedy in respect of any debt, liability, penalty, or forfeiture due to or incurred by or on behalf of the Corporation before the commencement of this Scheme may be continued, prosecuted, or enforced by or against the Local Board so far only as the property vested in the Local Board by this Scheme may extend, and no further.

ARTICLE VI.—The term "property" in this Scheme means and includes all property, real and personal, and all things in action, and all rights of common or commonable rights, and rights to toll, and all franchises, privileges, and rights which have any pecuniary value, and all charters, records, deeds, books, and documents, and includes any estate or interest, legal or equitable, in any property so defined.

THE Commissioners for the Conservancy of the River Mersey hereby give notice, pursuant to the 9th section of the Act 5 and 6 Victoria, cap. 110, intituled "An Act for the better preserving the Navigation of the River Mersey," that they have received from Mr. William Owen, of Warrington, Architect, a notice, given pursuant to the provisions of the above-mentioned Act, of his intention to erect a river wall at Atherton's Quay, Warrington, Lancashire, on the foreshore of the River Mersey, a copy of which notice is subjoined:—

"I, William Owen, of Cairo-street-chambers, Warrington, Associate of the Royal Institute of British Architects, practising as an Architect, Surveyor, and Valuer, do hereby give you notice that I intend, after and subsequent to the 15th day of June next, proceeding with the erection of a river wall at Atherton's Quay, Warrington, Lancashire, in accordance with plans deposited in the Office of the Commissioners for the Conservancy of the River Mersey, Whitehall, London, for and on behalf of Messrs. Monks, Hall, and Company Limited, Iron Manufacturers, Warrington, the owners of the land; such wall to commence

a little to the north-east of the sewer outlet belonging to the Corporation of Warrington, at Bank Quay, Warrington, and to run in a south-westerly direction for a distance of about 850 lineal feet, and to commence again at the Corporation sewer outlet at Atherton's Quay, Warrington, and to extend in a south-westerly direction about 450 lineal feet.

"The walls to be built according to section and plan deposited with you, and to be composed of Runcorn or other approved red sandstone and slag from the iron works.

(No. 80.)—ENGLAND.—WEST COAST.
LIVERPOOL BAY.

Intended Alteration in North Wall Light, Discontinuance of Hoylake Upper Light, and Exhibition of Lights from Dove Beacons.

THE Mersey Docks and Harbour Board has given notice, that on 15th May, 1886, the intensity of the fixed white light at North Wall, eastern side of River Mersey Entrance, will be in clear weather reduced so as to greatly diminish its brilliancy when bearing northward of E. by N. In foggy weather when Rock Light is not visible from North Wall Lighthouse, North Wall Light will not be thus dimmed, but will be displayed to the full range of its visibility.

Also, that on the same date the light hitherto exhibited from Hoylake Upper Lighthouse, eastward of Helbre Point, will be discontinued, and a red light of the fifth order will be shown from each of the two Dove Beacons in the new positions as undermentioned.

Also, that the two Dove Beacons have been removed from Dove Point, and will be placed in new positions about half-a-mile eastward of those they previously occupied, and will be about 420 yards apart in a S.E. $\frac{3}{4}$ S. and N.W. $\frac{3}{4}$ N. direction.

NOTE.—On the completion of the above mentioned changes vessels entering Rock Channel from seaward at night should skirt, as at present, the edge of East Hoyle Bank, with Bidston Light open eastward of Leasowe Light, and alter course to S. $\frac{1}{4}$ E. as soon as Hoylake Lower Light comes in sight on that bearing; after proceeding three-quarters of a mile, they will close the two red lights on Dove Beacons, which as soon as they are in line bearing S.E. $\frac{3}{4}$ S. should be steered for; after proceeding seven-eighths of a mile on this course Rock and North Wall Lights will appear in line bearing E. $\frac{1}{4}$ S.; the channel course will now be E. $\frac{1}{4}$ S. for a distance of one and a-half miles when Leasowe Light will disappear on a S.S.E. bearing; the course should then be altered, tide permitting, to E. $\frac{1}{4}$ N. for R 8 Black Can Buoy at the northern side of entrance to Rock Gut.

[The bearings and courses are magnetic. Variation $19\frac{1}{2}^{\circ}$ Westerly in 1886.]

CORK HARBOUR ENTRANCE.

(1.) *Roche Point Lighthouse—Intended Sector of Red Light.*

THE Commissioners of Irish Lights have given notice, that on or about 1st June, 1886, the light on Roche Point, eastern side of Cork Harbour Entrance, will be cut in order to guard vessels navigating in the vicinity of Pollock Rock :—

The light will show red from the bearing of N. 45° W., inshore to the land.

IRELAND—NORTH COAST.

LOUGH SWILLY ENTRANCE.

(2.) *Fanad Point Light—Intended Alterations and Auxiliary Light.*

Also, that on or about 1st September, 1886, the following alterations will be made in the light exhibited on Fanad Point, western side of Lough Swilly Entrance :—

The light will be an occulting light every thirty seconds, in the following manner :—Light for five seconds ; eclipse two and half seconds ; light twenty seconds ; followed by an eclipse of two and half seconds. It will show white seaward, to the bearing N. 12° W., and red from that bearing to the land, to guard vessels when near Swilly Rocks.

The light will be elevated 127 feet above high water, and should be visible in clear weather from a distance of 17 miles.

Also, that on the same date, an auxiliary light, elevated 72 feet above high water, will be exhibited from Fanad Point Lighthouse :—

The light will be a fixed white light, visible through an arc of 10°, or between the bearings of S. 5½° E. and S. 44° E., to mark Limeburner Rock.

[The bearings are magnetic, and are given from seaward. Variation (1) 22½°, (2) 23½° westerly in 1886.]

(1.) *Shoal South-west of Felgrundet.*

INFORMATION has been received of the existence of a shoal lying in the track of vessels navigating in-shore, with Felgrundet bearing N.E. by E. ½ E., distant about two miles.

This shoal (Yttergrund), about 110 yards long in a north-east and south-west direction, with a breadth of 50 yards, is composed of stones, and has a least depth of 18 feet with 5 fathoms around

Position, lat. 62° 24' 50" N., long. 21° 1' 25" E.

A beacon staff (red and white) with red and white flag, has been placed to mark Yttergrund, in 6 fathoms water, and about 55 yards westward of the shoalest part.

(2.) *Shoal North-west of Felgrundet.*

Also, of the existence of a shoal lying in the track of vessels navigating in-shore, with Felgrundet bearing S.E. ¼ E., distant about 4½ miles.

This shoal (Skomakargrund), about 38½ yards long in a north-east and south-west direction, with a breadth of 76 yards, is composed of stones, and has a least depth of 18 feet, with about 4 fathoms around.

Position, lat. 62° 28' 30" N., long. 20° 57' 30" E.

Skomakargrund is marked by two beacons placed in 23 feet water, and about 380 yards apart ; the northern beacon is a white staff with white flag ; the southern is a red staff with red flag.

[The bearings are magnetic. Variation 61½° Westerly in 1886.]
