By Decree of May 11th the Governor-General of Algeria has modified, as follows, the sanitary measures imposed upon arrivals from Italy:-

Quarantine of observation of five days for vessels coming either from Brindisi and the other ports of the Adriatic, or from the part of the coast between the Channel of Otranto and Naples

Observation of twenty-four hours for arrivals from the Mediterranean Coast, between Naples and the French frontier.

Arrivals from Sicily and Sardinia are admitted to free pratique.
