And whereas by Statute V for the Government of Charterhouse School it is provided that-

Admission to Senior Scholarships shall be determined by competitive examination, to be conducted as the Governing Body shall from time to time direct, and such Scholarships shall be open to all Boys who shall have been at the School at least twelve months previous to the commencement of the examination, and who shall be between the ages of fourteen and sixteen years.

And whereas on the twenty-fourth day of June, one thousand eight hundred and eighty-six, it was resolved by the Governing Body of the said School that it was expedient to alter the form and effect of the said Statute.

Now, therefore, wc, the Governing Body of Charterhouse School aforesaid, do hereby alter the form and effect of the said Statute.

The said Statute, as proposed to be amended, will be in the terms following :-

Admission to Senior Scholarships shall be determined by competitive examination, to be conducted as the Governing Body shall from time to time direct, and such Scholarships shall be open to all Boys who shall have been at the School at least twelve months previous to the commencement of the Examination, and who on the 15th day of July in the year of election shall be not less than fourteen nor more than sixteen years old.
