THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch, dated 25th ultimo, from Her Majesty's Representative at Copenhagen, enclosing the following copy of a Notice recently issued respecting quarantine in Denmark:—

Notice of the withdrawal of the Notice of the Minister of Justice of May 19th last.

The general inspection in accordance with the Law of July 2, 1880, 2nd paragraph, I, of ships arriving from Grimsby, which was ordered by the Notice of the Minister of Justice of May 19th last, as well as the prohibition contained in the aforesaid Notice of the Minister of Justice of the importation of the articles named in paragraph 32 of the law, are hereby withdrawn.

There will accordingly be no quarantine.

The provisions contained in the 2nd paragraph, I, of the Law of the 2nd July, 1880, to guard against the introduction of infectious diseases into the Kingdom, are accordingly in force with regard to the following places:—

Ports on the French coast between Nantes and St. Malo, both inclusive; Egersund, all ports in Chili, Florida, Jamaica, Martinique, Guadeloupe, St. Jago de Cuba, ports in the East Indies, Tonquin, and Cochin China, Trieste, all Egyptian sea ports, ports on the Red Sea, Rio de Janeiro, and Havana.

The prohibition of the importation into the kingdom of used linen, worn clothes, and used bed clothes, unless the articles named form part of the luggage of travellers, rags, used wadding, wool cardings, waste paper, hair and hides, remains in force against the following places:—

Ports on the French Coast between Nantes and St. Malo, both inclusive; Egersund, all ports in Florida, Jamaica, Martinique, Guadeloupe, and St. Jago de Cuba, all ports in the East Indies, Tonquin and Cochin China, and all ports in Chili.

The prohibition of the importation into the kingdom of used linen, worn clothes, and used bed clothes, in so far as these articles are not part of the luggage of travellers, remains in force as regards Rio de Janeiro and Havana. The cleansing under official supervision of linen articles of clothing and bed clothes brought from either of these two places in the luggage of travellers, is besides particularly ordered.

These provisions come into force from and after the 13th of September.

WHEREAS the Poor Law Commissioners, by a General Order bearing date the twenty-fourth day of July, one thousand eight hundred and forty-seven, made certain rules and regulations relating to the administration of relief to the Poor within certain Unions, including the said Fulham Union;

and by Article 182 of the said Order provision was made for the payment of special fees to Medical Officers in certain cases;

And whereas by an Order dated the thirty-first day of January, one thousand eight hundred and eighty-four, We, the Local Government Board, made certain regulations for the government of the Infirmary of the said Union, and by Article 32 of that Order We directed that all the provisions contained in the Orders in force in the said Union which related (among other matters) to the remuneration of Officers should apply to the Officers and Assistants appointed under that Order;

And whereas it is expedient to suspend, as hereinafter mentioned, the operation of Article 182 above mentioned as regards the Medical Officer for the Workhouse, and the Medical Superintendent of the Infirmary, of the said Union:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby suspend the operation, with respect to the Medical Officer for the time being for the Workhouse, and the Medical Superintendent for the time being of the Infirmary, of the said Fulham Union, of Article 182 above-cited, until We, by an Order under Our Seal of Office, shall otherwise direct.

NOTICE TO MARINERS.

(No. 300 of the year 1888.)

MEDITERRANEAN.—ITALY—WEST COAST.

(1.) *Leghorn—North and South Entrances Open.*

WITH reference to Notice to Mariners, No. 218, of 28th July, 1888, on the temporary closing of the northern entrance to the Port of Leghorn, during dredging operations :—

The Italian Government has given further notice, dated 13th September, 1888, as follows :—

Deepening the northern entrance being now completed, this channel is open to shipping.

Respecting the dredging at the south entrance of the port, vessels may pass either eastward or westward of the dredger, according to that vessel being at a greater or less distance from the curved mole.

The dredger will carry a red flag at the bow or stern indicating the side on which the passage is clear. Should the passages, eastward and westward of the dredger, be clear, she will show two flags. During the night the dredger will be anchored as close as possible to the curved mole, so as to leave the passage eastward of her clear; she will hoist the white light shown by vessels at anchor.

ITALY—SOUTH COAST.—GULF OF TARANTO.

(2.) *Beacon on Ugento Shoal.*

Also, has given notice, that on 9th September, a beacon was erected on Cavallo Rock, Ugento Shoal, eastern shore of Gulf of Taranto :—

The beacon consists of an iron staff surmounted by a frame ball (diameter about 6 feet), elevated 16 feet above the sea.
