river, and his experience in five former campaigns, beginning with the Afghan, and his example to the men were most valuable.

I recommend Naik Taliamand for early promotion. He suffered from fever most of the time, but would not go sick, and many other men suffering severely from Chin fever followed his example.

I recommend Lance-Naik Fazl Ahmad for early advancement. He has all the best qualities of the Pathan.

I recommend Hospital-Assistant Govindu Swamy Pillai to the notice of the Surgeon-General. He attended to Private Muhammad Hayát as soon as he was hit on the 31st under a hot fire from the enemy, who were under cover, and he was always cheerful and active. His conduct was most gallant.

I recommend Jemadar Birbal Nagarkoti, "H" Company, 43rd Gurkha Light Infantry, to the notice of his commanding officer. His conduct of the retreat from Langthobal and in subsequent operations was perfect.

Havildar Gunbir Rai was wounded in a most valuable counter-attack, but stuck to his rifle with his broken hand. I think all the men deserve reward.

A great reason of our success was the fact of the enemy wearing white coats. Every movement could be seen from afar and anticipated. Their musketry is, of course, contemptible.
