THE Queen has been pleased to grant unto Henry William Ramsay-Fairfax, a Second Lieutenant in the 2nd Regiment of Life Guards, eldest son and heir apparent of Sir William George Herbert Taylor Ramsay-Fairfax, of the Holmes, in the county of Roxburgh, and of Maxton, in the same county, Baronet, Her Royal licence and authority that he may continue to bear the surname of Ramsay in addition to and before that of Fairfax, and (in consequence of his marriage with Ada Christina, eldest daughter and coheir of Henry Spencer Lucy, late of Charlecote Park, in the county of Warwick, Esquire, deceased) that he may assume and bear the surname of Lucy in addition to and after those of Ramsay-Fairfax, and bear the arms of Lucy quarterly with those of his paternal family, and that the said surnames and arms may be used and borne by the issue of his said marriage; the said arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And also to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms.
