The QUEEN's Most Excellent Majesty in Council.

HEREAS by section twenty-six of "The Pluralities Act, 1838," after reciting that "Whereas in some instances tithings, hamlets, " chapelries, and other places or districts may be " separated from the parishes or mother churches " to which they belong, with great advantage, " and places altogether extra-parochial may "in some instances with advantage be annexed "to parishes or districts to which they "are contiguous, or be constituted separate " parishes for ecclesiastical purposes," it is, amongst other things, enacted "That when with " respect to his own diocese it shall appear to the " Archbishop of the Province, or when the Bishop " of any diocese shall represent to the said Arch-" bishop that any such tithing, hamlet, chapelry, place or district within the diocese of such "Archbishop, or the diocese of such Bishop, "as the case may be, may be advantageously " separated from any parish or mother church " and either be constituted a separate benefice by " itself or be united to any other parish to which " it may be more conveniently annexed, or to any " other adjoining tithing, hamlet, chapelry, place, " or district, parochial or extra-parochial, so as to " form a separate parish or benefice, or that any " extra-parochial place may with advantage be annexed to any parish to which it is contiguous, " or be constituted a separate parish for ecclesi-" astical purposes; and the said Archbishop or "Bishop shall draw up a scheme in writing (the " scheme of such Bishop to be transmitted to the " said Archbishop for his consideration) de-" scribing the mode in which it appears to " him that the alteration may best be effected, " and how the changes consequent on such " alteration in respect to ecclesiastical juris-" diction, glebe lands, tithes, rent-charges, and other ecclesiastical dues, rates, and payments, " and in respect to patronage and rights to pews, "may be made with justice to all parties in-" terested; and if the patron or patrons of the " benefice or benefices to be affected by such " alteration shall consent in writing under his or " their hands to such scheme, or to such modifi-" cation thereof as the said Archbishop may ap-" prove, and the said Archbishop shall, on full " consideration and inquiry, be satisfied with \* any such scheme, or modification thereof,

" and shall certify the same and such consent as " aforesaid, by his report to Her Majesty in " Council, it shall be lawful for Her Majesty in " Council to make an Order for carrying such " scheme, or modification thereof, as the case may " be, into effect."

And whereas the Right Reverend William Walsham, Lord Bishop of Wakefield, hath, pursuant to the enactment aforesaid, represented in a writing dated the eighteenth day of June one thousand eight hundred and ninety-two, to the Right Honourable and Most Reverend William Dalrymple, Lord Archbishop of York, as follows :-

" To the Right Honourable and Most Reverend Father in God William Dalrymple by Divine Providence Lord Archbishop of York, Primate of England and Metropolitan.

"We the Right Reverend William Walsham Lord Bishop of Wakefield do hereby represent to your Grace as follows :-

" That there is in the West Riding of the county of York and in our diocese of Wakefield the rectory of Cumberworth the parish whereof contains according to the last census a population of one thousand four hundred and seventeen.

"The net annual value of the benefice of Cumberworth is one hundred and forty-seven pounds.

"The patronage of the said rectory is vested in Wentworth Blackett Beaumont of Bretton Park in the said West Riding of the county of York Esquire and the Reverend James Whittam L. Th. is the present rector thereof.

"That there is also in the same West Riding and diocese the vicarage of Denby the parish whereof contains according to the last census a population of two thousand and thirty-eight. "The net annual value of the benefice of .

Denby is one hundred and seventy pounds thirteen shillings and eightpence.

"The patronage of the said vicarage is vested in the Reverend William Stephenson Turnbull M.A. vicar of Penistone in the said riding and diocese in right of his vicarage and the Reverend Alexander Barrington Orr is the present vicar thereof.

" That a certain district of the said parish of Cumberworth known as Denby Dale lies immediately contiguous to the said parish of Denby and it is proposed to erect a mission chapel there for the convenience of the inhabitants thereof.

"That the patrons and incumbent of the said

rectory of Cumberworth and of the said vicarage of Denby are consenting parties to the separation and annexation hereinafter proposed as is testified by their respective hands to the consents hereto annexed.

"That it appears to us that a certain portion of the parish of Denby immediately adjoining the said district of Denby Dale and more particularly described and delineated in the scheme and plan hereunto annexed may under the provisions of the Acts of Parliament passed in the first and second years of the reign of Her present Majesty chapter one hundred and six and the second and third years of Her said Majesty chapter fortynine be advantageously separated from the said parish of Denby and be united and annexed to the said parish of Cumberworth for all ecclesiastical purposes.

"That pursuant to the directions contained in the twenty-sixth section of the first-mentioned Act of Parliament we the said Lord Bishop have drawn up a scheme in writing appended to this representation describing the mode in which it seems to us that the alterations above proposed may be best effected and how the changes consequent upon such alterations may be made with justice to all parties interested and we do submit the same to your Grace to the intent that your Grace may if on full consideration and enquiry you shall be satisfied with the said scheme certify the same and such consents as aforesaid to Her Majesty in Council.

"Given under our hand the eighteenth day of June one thousand eight hundred and ninety-two. "Wm. Walsham Wakefield.

And whereas the said scheme drawn up by the said Bishop and the consents referred to in the said representation are as follows : --

#### " The SCHEME.

"It is proposed to separate a certain portion of the parish of Denby in the West Riding of the ccunty of York and diocese of Wakefield (which portion is particularly described in the schedule hereunder written) from that parish and to annex the same for ecclesiastical purposes to the parish of Cumberworth in the same riding and diocese. The vicar of the parish of Denby shall cease to have cure of souls within the said portion of the parish of Denby and the rector of the parish of Cumberworth shall have exclusive cure of souls within the limits thereof.

"The fees for marriages churchings burials and other offices of the church performed for the inhabitants of the said portion of the parish of Denby or arising within the limits of the same and usually payable to the incumbent of a benefice shall belong to the rector of Cumberworth.

"No alteration shall be made as to the patronage or (save as aforesaid) as to the endowment of either of the two benefices affected by this scheme.

#### " The SCHEDULE above referred to.

"All that portion of the parish of Denby in the West Riding of the county of York and diocese of Wakefield immediately adjoining the parish of Cumberworth in the same riding and diocese and bounded thereby on or towards the west and on or towards the north partly thereby and partly by a road known as White Close-lane on or towards the south-east by a road known as Hollin Edge on or towards the north-east by a road known as Pussy-lane and on or towards the south by the (late) Barnsley and Shepley-lane Head turnpikeroad which said portion of the parish of Denby is delineated on the plan hereunto annexed and thereon coloured round with a red verge line.

#### " CONSENTS.

"We Wentworth Blackett Beaumont of Bretton Park in the said West Riding of Yorkshire Esquire M.P. the patron or person entitled to present to the above-named benefice of Cumberworth in case the same were now vacant and the Reverend James Whittam Clerk in Holy Orders L. Th. the present incumbent of the said vicarage of Cumberworth and we the Reverend William Stephenson Turnbull Clerk in Holy Orders M.A. vicar of Penistone in the said West Riding and as such vicar the patron or person entitled to present to the above-named benefice of Denby in case the same were now vacant and the Reverend Alexander Barrington Orr Clerk in Holy Orders B.A. and the present incumbent of the said vicarage of Denby do hereby respectively signify our assent to the foregoing representation and scheme and to the several matters and things therein stated and proposed.

"Given under our hand this fifteenth day of June one thousand eight hundred and ninety-two.

And whereas the said scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration :

And whereas the said Archbishop, being satisfied with the said scheme, hath certified the same and the consents aforesaid to Her Majesty in Council, by his report dated the ninth day of July one thousand eight hundred and ninety-two, which said report is in the words and figures following :-

## " To the Queen's Most Excellent Majesty in Council.

"We the undersigned William Dalrymple Lord Archbishop of York Primate of England and Metropolitan do hereby report to Your Majesty in Council.

"That we have received from the Right Reverend William Walsham by Divine permission Lord Bishop of Wakefield a representation in writing under the hand of the said Lord Bishop bearing date the eighteenth day of June one thousand eight hundred and ninety-two stating that it appears to the said Lord Bishop that a certain portion of the parish of Denby in the West Riding of the county of York and in the diocese of Wakefield may be advantageously separated from that parish and be united and annexed to the parish of Cumberworth in the same county and diocese for all ecclesiastical purposes.

"That to the same representation is annexed a scheme in writing describing the mode in which it appears to the said Lord Bishop that the aforesaid alteration may be best effected and how the changes consequent upon such alteration in respect to ecclesiastical jurisdiction dues rates and payments may be made with justice to all parties interested.

"That the said Lord Bishop hath also transmitted to us the consents in writing of the patrons and incumbents of the benefices affected by the said scheme.

"The said representation and scheme of the said Lord Bishop and the consents before referred to are hereunto annexed.

"And we the said Archbishop being on full consideration and enquiry satisfied with the said scheme do hereby pursuant to the Act of the first and second years of Your Majesty's reign chapter one hundred and six certify the same and such

to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said scheme into effect.

"As witness our hands this ninth day of July in the year of our Lord one thousand eight hundred and ninety-two.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 17th September, 1892, from Her Majesty's Representative at Tunis, enclosing a Notice published in the "Journal Officiel Tunisien" relating to quarantine.

The following is a translation of the material points thereof :-

. Ships coming from ports of the Black Sea, Germany, the Netherlands, Belgium, and ports of France, where the existence of cholera is officially established, will be admitted to Tunis (if laden with non-susceptible goods), on condition of perform-ing eight days' quarantine, and undergoing such measures of disinfection as shall be ordained by the Health Authorities.

Ships coming from the above-mentioned ports and laden with susceptible goods will only be admitted to Tunis after being disinfected at one of the three lazarets of Mahon, Azinara, and Marseilles, unless meanwhile the prohibition of | rendre librement à l'hotel ou prendre un apparte-

Vessels from Dunkirk and Dieppe will be subjected to the above regulations.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 23rd September, 1892, from Her Majesty's Representative at Belgrade, enclosing the following Circular relating to health precautions adopted in Servia :--

Les voyageurs, venant des contrées contaminées, mais dont le bon état de santé aura été constaté pourront, après avoir subi la visite médicale, se ment privé. Mais ils resteront soumis à la surveillance médicale. Dans ce but, à leur arrivée, ils indiqueront leur adresse, de façon à ce que les medecins puissent les visiter ultérieurement.

Les navires, ayant à bord des malades, ou des voyageurs présentant des symptomes suspects, devront arborer un pavillon jaune, et attendre la visite médicale. Dans les stations serbes, seuls les nationaux pourront être débarqués (malades ou décedés).

Les voyageurs, venant des pays contaminés et traversant la Serbie, seront transportés dans des wagons spéciaux, et complètement séparés, ou ils seront l'objet d'une surveillance particulière de la part des conducteurs. Ces memes voyageurs devront se munir de vases pour les déjections. Ces mesures de précaution sont, des à présent, applicables à l'Orient Express.

#### Sofia, September 21, 1892.

The Sanitary Council of the Principality, in its sittings of the 16th, 17th, and 19th, has decided on the following measures-

(a.) Barrels, casks, and other objects containing alcohol will be exposed to the air for five days, and disinfected at the expense of the owner of the goods

(b.) The entry into Bulgaria of all parcels coming by post from contaminated places will be forbidden, with the exception of groups of coin and packets of medicine, which will be disinfected.

(c.) Arrivals from all the Asiatic Ports of the Black Sea will be subjected to a quarantine of eleven days.

(d.) Medical certificates will be delivered to travellers to prove that they have undergone the required quarantine.

(e.) Besides those places which have already been mentione !, such as Hamburg, Antwerp, Havre, &c., the following will be considered as contaminated :

1. All the coasts of Northern Europe from Kronstadt (Gulf of Finland) inclusive, as far as, but not including, Cherbourg. 2. In England, Glasgow, Liverpool, Grimsby,

Scilly, and London.

3. Kurachee and all the coast of Persia.

 All the Vilayet of Erzeroum.
 The coast of Africa, between Cape Guardafuy and Massowah, inclusive.

6. The coast of the Yemen from Hodeidah, inclusive to, but not inclusive of, Lith.

#### (Translation.)

Health Office, Smyrna,

MONSIEUR LE CONSUL, September 17, 1892.

WITH reference to preceding Circulars, I have the honour to inform you that, until further notice, the following regulations are applied to arrivals from the contaminated places mentioned in previous Circulars.

1. Free pratique will be given after the regular medical visit to a vessel arriving at Smyrna fifteen days after leaving a contaminated port, arrivals from which are subject to five days' quarantine.

2. Free pratique will be given after a favourable medical visit to a vessel arriving at Smyrna twenty-four days after leaving a contaminated. port, arrivals from which are subject to a quarantine of ten days.

3. The benefits of these dispositions shall only be applied to such vessels as are furnished with a clean bill of health delivered at a non-contaminated port, after they shall have left a contaminated port, and provided also that the medical visit proves the health on board to be good.

term of fifteen or twenty-four days will be subjected to regulations in force, viz., five or ten days, according to the places they come from and the ports they call at.

5. Quarantine purged at a foreign port will reckon towards reducing the quarantine imposed here.

N.B.-The Ottoman guardship "Tewfikieh" is entrusted with the Sanitary Police at Yenikalé (New-Castle).

All vessels bound for Smyrna are required to stop off the Castle in order to undergo the interrogation by a Health Officer. If the vessel is subject to quarantine the Master will be called upon to put back to Clazomene, where his quarantine will be performed.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 23rd September, 1892, from Her Majesty's Representative at Lisbon, enclosing the following extract from the Official Journal of that date :---

#### (Translation.)

#### NOTICE.

By order of the Government, notice is hereby given, that :-

1. The admission into the Continental part of the Kingdom and into the adjacent islands of any of the articles mentioned in the Notices of the 13th and 23rd of last July and of the 14th instant is absolutely prohibited, as well as of the undermentioned articles, if coming from any regions infected with cholera ;-

Articles of furniture, such as carpets, curtains, and "Portières," articles of furniture already used or stuffed or lined with any kind of texture, shoes and clothes already used (excepting passengers' luggage), vegetable filaments, manure, decomposed organic matters, animal matters, such as blood, hides, skins and hairy substances, feathers in their natural state, hair and bones, fresh meat or in sausages or salted, hams and sausages, glue, gelatine, lard and butter, grape or olive stones, bread or products made from bread, yeast, live or dead birds, fresh, dried, or salted fish, eggs, honey, raw wax, milk and dairy produce, preserves, carriages already used, biscuits, tobacco, either raw or manufactured, and any other articles and animals to which the same prohibition may be extended, saving, however, the clause laid down in the Maritime Sanitary Notice No. 501-so long as it is not altered-the same being applicable to all articles brought from any infected places.

2. Until further notice, mineral ore and coal in bulk and in open waggons without any other cargo, as well as metals in the rough or wrought and in non-susceptible wrappers, timber for building purposes, or cork in open waggons without any other kind of cargo, and also chemical disinfecting substances under any tare will be freely admitted through the frontier.

3. Permission may be granted, under such terms and clauses as may be deemed expedient, by order of the Minister for the proper Department, in answer to a petition addressed to him with reference to a particular shipment, such order to be given in view of the place of origin as duly proved, of the conditions of shipment, and of other circumstances worthy of consideration in

'4. Vessels arriving before the expiration of this | any particular case, but not to form a precedent in any way for any case other than that for which it may be given, for the admission, through the frontier, from any regions infected with cholera, of any animals the entrance of which shall not be absolutely prohibited, of fruits in closed boxes. and in transit for any foreign country, of medicines, of any drugs of a vegetable or animal nature, of any liquids in wooden casks, as well as of any other articles to which this measure may be extended.

> 4. All other articles of trade or of personal use not comprised in the foregoing rules brought to this country through the frontier are to be disinfected at the frontier stations, which are already or may hereafter be established, either by means of a stove under steam pressure or by the process of fumigation by sulphur, according to the nature of the article, or solely by the last-named process, in the event of the necessary apparatus not having yet been set up in order to carry out the first. process.

> 5. Any articles in the luggage of any passenger, of which the entrance is prohibited, will be destroyed.

> 6. The foregoing rules are to be enforced in the case of articles coming from Spain, unless they are accompanied by a Consular Certificate in order to prove the place of origin.

> 7. All postal mails in transit from any regions infected with cholera will be admitted without undergoing the process of disinfection provided they are sent in bags or wrappers properly tarred or else saturated with carbolic acid.

> 8. The rules contained in the Notices of the 23rd and 27th of July last, as regards the medical inspection of passengers at the proper stations and their obligation to appear before the proper authority, continue to be in force; in case of disobedience such passengers will be dealt with in accordance with Article 188, section 1, of the Penal Code.

> 9. No vessel will be allowed to land any persons, to discharge any articles of merchandize, or to receive cargo at any port in this country or in the adjacent islands should there have been any case of cholera on board, but every assistance. that such vessel may absolutely require will be rendered in accordance with the regulations.

> 10. Saving the rule laid down in the preceding Article, every ship coming from any port declared to be infected with cholera, or that may have called or put into any port so infected, shall be subject to quarantine and disinfection; the passengers will have to perform the proper amount of rigorous quarantine, and the whole cargo must be disinfected in the manner which may be best adapted to its nature and quality.

> In like manner, the whole cargo of a ship coming from any port suspected of cholera, or having touched at any port so suspected, shall be disinfected in the manner set forth in the General. Maritime Sanitary Regulations.

> 11. In the event of there being an urgent necessity of sanitary precautions, any of the above-mentioned rules may be altered without previous notice, which will however be given as soon as possible.


WHEREAS by a General Order dated the 24th day of July, 1847, addressed to the Guardians of the Poor of the said Hackney Union, among others, the Poor Law Commissioners prescribed Rules and Regulations as to the Meetings and Proceedings of the said Guardians, and by Article 41 (Firstly), and Article 202 (No. 1) of the said Order provision is made with regard to keeping Minutes of the proceedings at the Meetings of the said Guardians, entering the said Minutes in a book, submitting the same so entered for authentication by the signature of the presiding Chairman, and as to reading such Minutes; and it is expedient that, so far as regards the said Hackney Union, further provision should be made as hereinafter mentioned :

Now, therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby, so far as regards the said Hackney Union, alter the said Order, and Direct as follows :-

ARTICLE I.-If the said Guardians shall so direct, it shall be the duty of the Clerk to the Guardians to prepare for printing the Minutes of the proceedings at their Meetings and, before every ordinary Meeting, to attach the printed Minutes of the preceding ordinary Meeting, and of any Extraordinary Meeting which may have been held since such ordinary Meeting, to those which have already been confirmed, and at every ordinary Meeting to submit the Minutes of the preceding ordinary Meeting, and of any such Extraordinary Meeting, to be authenticated by the signature of the presiding Chairman.

ARTICLE II.—If the said Guardians shall so direct, it shall also be the duty of the Clerk to the Guardians to send to each Guardian, by post or otherwise, forty-eight hours at least before each ordinary Meeting of the Guardians, a printed copy of the Minutes of the last ordinary Meeting and of every other Meeting of the Guardians held since the last ordinary Meeting; and if, in pursuance of any such direction, a printed copy of such Minutes shall have been so sent to each Guardian it shall not be necessary that the Minutes so sent shall be read at the next ordinary Meeting if at such Meeting the Guardians resolve that such Minutes be taken as read. Any such Resolution shall be entered upon the Minutes in lieu of an entry to the effect that the Minutes have been read.


