and Birmingham Branch Line of the Midland Railway, upon the boundary which divides the said consolidated chapelry of Saint Matthew, Moorfields from the new parish of Saint Lawrence Bristol aforesaid."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patron and to the incumbents of the two cures out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and incumbents have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Gloucester and Bristol at Bristol and Gloucester respectively, C. L. Peel.

And whereas Orders in Council have been made directing the discontinuance of burials in the churchyards hereinafter mentioned from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards be postponed:

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be postponed as follows, viz.:—

In the parish churchyard of Grasmere, in the county of Westmorland, until the thirtieth day of September, one thousand eight hundred and ninety-three.

In Attleborough Churchyard, in the parish of Nuneaton, in the county of Warwick, until the thirtieth day of June, one thousand eight hundred and ninety-three.

In the parish churchyard of Talland, in the county of Cornwall, until the thirtieth day of September, one thousand eight hundred and ninety-three.

In the parish churchyard of South Witham, in

the county of Lincoln, until the thirty-first day of October, one thousand eight hundred and ninety-three:

In the parish churchyard of Kingsbury Episcopi, in the county of Somerset, until the thirty-first day of July, one thousand eight hundred and ninety-three.

And whereas by an Order in Council of the eighteenth August, one thousand eight hundred and ninety-two, burials were directed to be discontinued in the churchyard of the parish of Syresham on and after thirty-first day of March, one thousand eight hundred and ninety-three:

And whereas a representation has been made by the Right Honourable Herbert Henry Asquith dated the sixth day of April, one thousand eight hundred and ninety three, stating that he is of opinion that the time fixed for the discontinuance of burials in the said churchyard should be altered to the thirtieth day of April, one thousand eight hundred and ninety-three. Now therefore Her Majesty by and with the advice aforesaid is pleased to order and it is hereby ordered that the time for the discontinuance of burials in the said churchyard be altered accordingly.
