THE Board of Trade have received, through the Secretary of State for the Colonies, a copy of a Government Notice (No. 105), dated 23rd June, 1893, issued by Her Majesty's Representative at Malta, stating that vessels arriving from any port of France are to undergo seven days' quarantine, reckoned from the date of their arrival at Malta, unless twenty-one days have elapsed from the date of their departure from France.

Such vessels shall be permitted, under the direction of the Collector of Customs, to discharge goods (which are not susceptible of communicating contagion) by means of the vessel's crew on lighters, or to employ, for handling cargo, local labourers under quarantine.
