was, among other things, enacted that "it should " be lawful for Her Majesty, from time to time, by Warrant under Her Sign Manual, to appoint " any person to fill any vacancy among the Com-"missioners of the Patriotic Fund which has arisen either before or after the passing of this " Act, from death, resignation, or otherwise;"
