(b.) The quarantine of five days imposed on the Turkish-Persian frontier, between Bayazid and Hameguine, on arrivals from Persia, is suppressed.

(c.) The quarantine of five days imposed on arrivals from Roumania (Danube and Black Sea) is reduced to 24 hours' observation at Kavak.
