THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of the following Telegram, dated 24th January, 1894, from Her Majesty's Representative at Athens: -- "Five days' observation Salonica."

A Despatch from Her Majesty's Minister at Athens, dated 6th January, 1894, has also been received, reporting that Article 4 of the Regulations for the prevention of the introduction of cholera has been further modified by Royal Decree, and now runs as follows:-

Article 4.

Vessels proceeding from cholera-infected places shall be subjected to an effective quarantine of ten days if their voyage has lasted less than fifteen days.

If their voyage has lasted fifteen full days they shall be subjected to a quarantine of observation

of five days.

If their voyage has lasted more than fifteen days, but less than twenty, the twenty days shall

be completed (in quarantine).

This complementary quarantine shall be performed in any port where there is a health officer of any class and a doctor, under exactly the same conditions as those under which quarantine of observation is performed.

If their voyage has lasted more than twenty days, they shall receive free pratique after the depositions of the crew have been taken and a

severe medical inspection carried out.
