THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 3rd August, 1894, from Her Majesty's Acting Consul at Aleppo, stating that the Sanitary Authorities have informed him that quarantine has been extended from Marmaritzta to Pyass inclusive. As a measure of precaution the Vilayet of Aleppo has imposed five days' observation on arrivals from Caramania, fixing as last limits Pyass inclusive.

In case of cholera the vessels must proceed to the quarantine stations.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 18th August, 1894, from Her Majesty's Representative at Copenhagen, stating that sanitary precautions are declared against vessels arriving from the Netherlands, or having communicated with ships coming from ports of that country.

Passengers are subject to medical inspection, and merchandize coming from that country is either forbidden entry into Denmark, or is subjected to disinfection, according to regulation.
