SUFFOLK PROHIBITED DISTRICT (SWINE-FEVER) ORDER OF 1895.

By the Board of Agriculture.
THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Act, 1894, and of every

other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Schedule.

1. Swine shall not be moved by land or by water out of the District described in the Schedule to this Order.

Prohibition of Movement out of District in

Provided that nothing in this Article shall be deemed to apply to the movement of swinc where they are moved through the District described in the Schedule to this Order by railway from a place outside that District to another place outside that District without unnecessary delay and without the swine being untrucked or rebooked within that District.

Offences.

2.—(1.) If a pig is moved in contravention of this Order, the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be
