•on retirement to any officer on account of time on Half-Pay in excess of two years subsequent to his last employment: that these new provisions in regard to non-service be applied only to those •officers coming on each list after the date of Your Majesty's Order in Council; that Lieu-•tenants compulsorily retired before the completion •of six years' service in that rank on account of illness attributable to the service, be allowed to •count all their junior service towards retirement; we would further submit :--

- "1. That the optional retirement of Admirals and Vice-Admirals at the age of 55, of Rear-Admirals at the age of 50, and of Captains at 45, allowed as a temporary measure by Your Majesty's Order in Council of fifth Angust, one thousand eight hundred and seventy-five, be discontinued.
- ⁴¹ 2. That provisions in Your Majesty's Order in Council of twenty-ninth November, one thousand eight hundred and seventy-nine, authorizing us to continue the retirement, without limit, of Lieutenants on the terms sanctioned in paragraph twenty-four, chapter X of Your Majesty's Order in Council of twenty-second February, one thousand eight hundred and seventy, should also cease.

"Treasury have concurred in these proposals."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
