HER Majesty in Council was, this day, pleased to declare Her Consent to a Contract of Matrimony between Her Royal Highness the Princess Alexandra Loui-e Olga Victoria, third daughter of His Royal Highness Ernest Albert, Duke of Saxe-Coburg and Gotha and Duke of Edinburgh, and his Consort Her Royal and Imperial Highness the Duchess of Saxe-Coburg and Gotha, Duchess of Edinburgh, Grand Duchess of Russia, and the Hereditary Prince Ernest William Frederic Charles Maximilien of Hohenlohe-Langenbourg, son of the Prince of Hohenlohe-Langenbourg; which Consent Her Majesty has caused to be signified under the Great Seal and to be entered in the books of the Privy Council.

W HEREAS by Treaty, grant, usage, sufferance and other lawful means, Her Majesty the Queen has power and jurisdiction in and over Cyprus:

And whereas Her Majesty on the fifteenth day

of July, one thousand eight hundred and eightyone, made an Order in Council, entitled the Cyprus
Extradition Order in Council, 1881, and on the
eighth day of March, one thousand eight hundred
and ninety-five a further Order in Council to
amend the same, entitled the Cyprus Extradition
Order in Council 1895:

And whereas it is expedient to define certain expressions contained in the said Orders in Council:

Now therefore Her Majesty by virtue of the powers in this behalf by "The Foreign Jurisdiction Act, 1890," or otherwise, in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order and declare and it is hereby ordered and declared as follows:—

1. This Order may be cited as the Cyprus Extradition Order in Council 1895 No. 2, and shall be construed as one with the Cyprus Extradition Order in Council, 1881 and the Cyprus Extradition Order in Council, 1895.

2. In the Cyprus Extradition Orders in Council 1881 and 1895 the expression "the Ottoman Government" shall be taken to include the Government of any autonomous or semi-autonomous State within the dominion of the Sultan of Turkey.

3. In the Cyprus Extradition Order in Council, 1881 the expressions "Ottoman depositions or statements" "Ottoman Warrants or other judicial instruments authorizing apprehension" and "Ottoman Certificates or judicial instruments stating a conviction" shall be taken to include depositions or statements taken or made, and warrants, certificates or judicial instruments issued in any part of the Ottoman Dominions.

And the Right Honourable Joseph Chamberlain, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.
