in France, recently published in the Journal Officiel, viz.:—

LE Président de la République Française; Sur le rapport des Ministres de l'Intérieur et des Finances;

Vu l'Article 1er de la loi du 3 Mars, 1822, sur

la police sanitaire;

Vu la Convention sanitaire internationale signée à Dresde le 15 Avril, 1893, et le decret du 22 Mai, 1891, portant promulgation, en France, de ladite convention;

Vu l'avis du comité de direction des services de l'hygiène,

Décrète:

ART. 1er. Est interdite jusqu'à nouvel ordie l'importation en France des drilles et chiffons ainsi que des linges des corps, hardes, vêtements portés et objets de literie tels que matelas, couvertures, etc. (non transportés comme bagages) venant d'Egypte.

ART. 2. Le Ministre de l'Intérieur et le Ministre des Finances sont chargés, chacun en ce qui le concerne, de l'exécution du présent décret, qui sera inséré au Bulletin des Lois et publié au

Journal Officiel.
