D.S.O. (Royal Artillery), to safeguard the Dongola District, but it is satisfactory to note that the tribes inhabiting the Bayuda Desert are almost without exception loyal to the Egyptian Government.

On 31st October the desert railway from Wadi Halfa was opened to Abu Hamed, and the extension towards Berber was at once begun. The rapid completion of this line, which has greatly facilitated communications, reflects much cre it on Lieutenant-Colonel J. G. Maxwell, D.S.O. (Commanding Nubia District), Lieutenant E. P.C. Girouard, D.S.O. (Royal Engineers), and his Staff, and on all officers and men employed on this undertaking, which has been successfully accomplished in almost record time, under great vicissitudes and during exceptionally hot weather.

In conclusion, it is my pleasant duty to record my appreciation of the excellent services of not only the officers and troops mentioned above, but also of the whole force of the Egyptian Army in the Sudan, who, whether British or Native, officers or men, willingly and ably carried out the often arduous duties they were called upon to perform, and maintained throughout the trying summer heat most excellent discipline and soldierlike spirit.

. As fuller accounts have from time to time been submitted to you dealing in detail with the various movements described, I have thought it merely necessary in the above despatch to touch on the salient points of the recent operations, which have resulted in retaking for Egypt upwards of 300 miles of the Nile Valley, besides the whole of the Eastern Sudan, and in freeing the inhabitants of these districts from terrible oppression.

No. 1379 .- Paragraph 15 of Major-General Sir B. Blood's Despatch No. 5, dated 27th October, 1897, published in G.G.O., No. 1317, of the 3rd December, 1897, is revised and should read as follows :-

15. The right column under Lieutenant-Colonel Vivian, 38th Dogras, consisting of six companies and a detachment of Sappers, was directed along the eastern side of the Mamund Valley on the villages of Shinkot, Chingai 1st, Damadolah and Badam Kili; the central column under Colonel Goldney, 35th Sikhs, consisting of ten companies (4 of the Buffs and 6 of the 35th Sikhs), four guns, one squadron and a detachment of Sappers, was directed against the villages of Munar, Hazarnao and Badalai; while the left column, under Major Campbell of the Guides, was composed of seven companies (2 of the Buffs and 5 of the Guides), and a detachment of Sappers, and was directed along the right bank of the Watelai ravine parallel to the centre column.
