No. 32.-Government Notice.-Quarantine.

WHEREAS it appears to the Governor in Council that bubonic plague prevails on the French Ivory Coast :

It is hereby declared that the French Ivory Coast extending from the boundary of the Gold Coast on the east to the boundary of Liberia on the west is an infected place within the meaning of Section VI of "The Quarantine Ordinance, 1882."

And notice is hereby given, that all vessels arriving at any port in this Colony from the French Ivory, Coast as defined above, or any

place in free communication therewith, will be placed in quarantine.

To the Guardians of the Poor of the Camelford Union ;---


And to all others whom it may concern.

WHEREAS by an Order dated the 5th day of June, 1869, the Poor Law Board suspended, so far as regards the Camelford Union, the operation of Articles 177, 178, 179, 180, and 181 of the General Order of the Poor Law Commissioners dated the 24th day of July, 1847;

And whereas by the said Articles provision is made for the payment of special fees to Medical Officers in certain cases, and it is expedient that the suspension of the said Articles should be removed :
