(Translation.)

New Sanitary Regulation.

Yesterday the new Sanitary arrangements came

into force in our port.

In future instead of the Health Officers visiting the ships arriving at our port in their boat, it will be the Captains on board who will proceed in their boat to the Maritime Health Office. The boat will fly a yellow flag.

In the event of the ship having any sick person who might be the cause of an epidemic, the Captain will not disembark, but will hoist a yellow flag and underneath a red one, when the Health Authorities will arrange for the vessel to be put

into quarantine.

It will be well then for consignees and merchant Captains to inform themselves of and put in practice these Regulations in order not to incur the corresponding fines as happened with the first ships which entered yesterday and did not know of the enforcement of the new Regulation. The new Health Regulations indicate the penalty incurred by the owners of boats mooring alongside, communicating with or receiving anything from a quarantine ship.

The fines vary from 15 to 150 pesetas.
