#### THE FAIRS ACT, 1873.

##### BRIGG FAIR.

THE Secretary of State for the Home Department hereby gives notice, that by Memorial, dated the 10th instant, a representation has been duly made to him by Valentine Dudley Henry Cary-Elwes, Esq., of Billing Hall, in the county of Northampton, that a Fair has been annually held at Brigg, in the county of Lincoln, on the 5th August, and that it would be for the convenience and advantage of the public that such Fair should for the present year be held on the 3rd August.

On the 1st day of July, 1901, the Secretary of State will take such representation into consideration, and any person who may desire to object to the alteration of the date of the said Fair for the present year should intimate his objections to the Secretary of State before that day.

#### WILD BIRD (ENGLAND).

The Wild Birds Protection (County of Cambridge) Order, 1901.

Dated 12th June, 1901.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Cambridge, I hereby make the following Order:—

##### Title.

I. This Order may be cited as "The Wild Birds Protection (County of Cambridge) Order, 1901."

##### BIRDS.

*The Goldfinch and the Great Bustard protected during the whole of the Year.*

II. During the period between the 31st day of July in any year, and the 2nd day of March following, the killing or taking of the Goldfinch and the Great Bustard is prohibited throughout the County of Cambridge.

##### EGGS.

*All Eggs protected within a certain Area*

III. The taking or destroying of Wild Birds' Eggs is prohibited within that part of the County of Cambridge known as Wicken Sedge Fen during the period expiring on the 7th April, 1904.
