REGULATIONS respecting Open Competitive Exam-inations for the Situation of Sorter-Telegraphist Learner in London in the Department of the Postmaster-General.

These Regulations are liable to alteration for future Examinations.

1. Candidates will be required to satisfy the Civil Service Commissioners

- (a.) That their age on the day of the Examination is not less than  $16\frac{1}{2}$  nor more than  $18\frac{1}{2}$  (the half year being reckoned by calendar months).
- Note.--In reckoning age for competition, persons who have served for two full consecutive years in the Army or Navy, or
- in any Civil situation to which they were admitted with the Certificate of the Civil
- Service Commissioners, or as Registered Copyists in connection with the Civil Service, may deduct from their actual age any time not exceeding five years which they may have spent in such service.

(b.) That they are duly qualified in respect of health and character. Note.--No Candidate will be eligible for

- appointment who fails to satisfy the Medical Officers of the Post Office that he is free from any physical defect, disease, or weakness which would be likely to interfere with the proper discharge of his duties, or with 'his regular and continuous attendance.
- Candidates must be at least 5ft. 2in. in height, and no Officer will be retained in the service who does not attain the height of 5ft. 4in.
- before completing his nineteenth year. Re-vaccination will be required before appointment unless the candidate exhibits good marks of primary and secondary vaccination, or good marks of vaccination with definite evidence of having had smallpox.

2. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.
