one thousand nine hundred and three, in the

words and figures following; that is to say:---"We, the Ecclesiastical Commissioners for England acting under the provisious of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four, of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninetyfour, have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Christ Church, North End, Finchley, and of the new parish of Saint Paul, Long-lane, Finchley, both in the county of Middlesex, and in the diocese of London.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the twenty-eighth day of May in the year one thousand eight hundred and seventy-two and published in the London Gazette on the thirty-first day of the same month certain contiguous portions of the parish of Finchley, of the new parish of Saint John Whetstone and of the new parish of the Holy Trinity, Finchley, in the said county of Middlesex and diocese of London were assigned as a consolidated chapelry to the con-secrated church called Christ Church situate at North Eud in the said parish of Finchley and the said consolidated chapelry was named 'The Consolidated Chapelry of Christ Church North End Finchley.'

"And whereas the said consolidated chapelry of Christ Church North End Finchley has under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four become a new parish of the character contemplated by that Act by the Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven and by the abovementioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the twenty-fourth day of September in the year one thousand eight hundred and eighty-six and published in the London Gazette on the twenty-eighth day of the same month certain contiguous portions of the said parish of Finchley and of the said new parish of Christ Church North End Finchley were assigned as a consolidated chapelry to the consecrated church of Saint Paul situate in Long lane in the said parish of Finchley and the said consolidated chapelry was named 'The Consolidated Chapelry of Saint Paul Longlane Finchley."

"And whereas the said consolidated chapelry of Saint Paul Long-lane Finchley has under the provisious of the above-mentioned Act of the sixth and seventh years of Her said late Majesty chapter thirty-seven become a new parish of the character contemplated by that Act, by the abovementioned Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Christ Church North End Finchley and of the said new parish of Saint Paul Long-lane Finchley should be altered in the manner which is hereinafter mentioned.

"Now therefore with the consent of the Right Honourable and Right Reverend Arthur Foley Bishop of the said diocese of London (in testimony | along the middle of Bow-lane for a distance of

whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Christ Church North End Finchley and of the said new parish of Saint Paul Long-lane Finchley shall be altered so that all those portions of the said new parish of Christ Church North End Finchley which are described in the schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Saint Paul Long-lane Finchley.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the new parish of Christ Church North End Finchley in the county of Middlesex and in the diocese of London and to be annexed to the new parish of Saint Paul Long-lane Finchley in the same county and diocese being :-

"1. All that portion of the said new parish of Christ Church North End Finchley which is bounded upon the north-west by the parish of Hendon upon the south-west by the parish of Finchley both in the said county and diocese upon the south-east by the said new parish of Saint Paul Long-lane Finchley and upon the remaining side that is say upon the north-east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul Long-lane Finchley from the said new parish of Christ Church North End Finchley at the junction of Ballards-lane with Newcomen-road and extending thence north-westward along the middle of Newcomen-road for a distance of six chains and a half or thereabouts to its north-western end and continuing thence north-westward in the same direction and in a straight line for a distance of thirty chains or thereabouts to a point in the middle of Dollis Brook upon the boundary which divides the said new parish of Christ Church North End Finchley from the said parish of Hendon.

"2. And also all that other portion of the said new parish of Christ Church North End Finchley which is bounded upon the south-west by the said new parish of Saint Paul Long-lane, Finchley, and upon the remaining sides that is to say upon the north-west upon the north-east and upon the east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Paul Long-lane Finchley from the said new parish of Christ Church North End Finchley at the junction of Etchingham Park-road with Ballards-lane and extending thence north-east-ward along the middle of Ballards-lane for a distance of six chains and a quarter or thereabouts to its junction with Granville-road and extending thence south-eastward along the middle of Granville-road for a distance of eighteen chains and three-quarters or thereabouts to its junction with Bow-lane and extending thence southward
