

"Now therefore, with the consent of the Right Reverend Handley Carr Glyn, Bishop of Durham, as Diocesan and also as the patron (in right of his See) as well of the vicarage of the said new parish of Christ Church, Gateshead, as of the rectory of the said parish of Saint John, Gateshead Fell, and with the consent of the Reverend James Steel, Vicar of the parish of Heworth, in the said county and diocese, as the patron (in right of his vicarage) of the vicarage of the said new parish of Saint Alban, Heworth (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Christ Church, Gateshead, of the said parish of Saint John, Gateshead Fell, and of the said new parish of Saint Alban, Heworth, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint George, Gateshead, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint George, Gateshead.'

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint George, Gateshead, comprising:—

"I. All that portion of the new parish (some-time district chapelry) of Christ Church, Gateshead, in the county of Durham and in the diocese of Durham, which is bounded upon the west by the district of Saint Chad, Bensham, Gateshead, upon the south-east partly by the new parish of Saint Helen, Gateshead, and partly by the parish of Saint John, Gateshead Fell, upon the north-east partly by the last-named parish and partly by the new parish of Saint Edmund, Gateshead, all in the said county and diocese, and upon the remaining side, that is to say, upon the north-west, by an imaginary line commencing upon the boundary which divides the said new parish of Saint Edmund, Gateshead, from the said new parish of Christ Church, Gateshead, at the junction of Durham-road with the road called or known as Bright-terrace, and extending thence south-westward along the middle of Bright-terrace for a distance of eight chains or thereabouts to its junction with Prince Consort-road, and extending thence south-eastward along the middle of Prince Consort-road for a distance of seven chains or thereabouts to its junction with the road called Saint Alban's-terrace, and extending thence south-westward along the middle of Saint Alban's-terrace for a distance of eight chains or thereabouts to its junction with that part of Avenue-road which is known as Elmgrove-terrace, and extending thence south-eastward along the middle of Avenue-road for a distance of eight chains or thereabouts to its junction with the road called or known as Westfield-terrace, and extending thence westward along the middle of Westfield-terrace for a distance of five chains and a half or thereabouts to its junction with the roadway running between the backs of the houses on the south-western side of Roodsley-avenue and the backs of the houses on the north-eastern side of Brinkburn-avenue,

and extending thence south-eastward along the middle of the said roadway for a distance of sixteen chains and a half or thereabouts to its junction with the roadway running along the backs of the houses on the northern side of Saltwell View, and extending thence generally westward along the middle of the last-mentioned roadway (thereby crossing Brinkburn-avenue, Eastbourne-avenue, Westbourne-avenue and Windsor-avenue) for a distance of thirteen chains or thereabouts to the point where such roadway meets Rectory-road, upon the boundary which divides the said new parish of Christ Church, Gateshead, from the said district of Saint Chad, Bensham, Gateshead.

"II. And also all that contiguous portion of the said parish of Saint John, Gateshead Fell, which is bounded upon the south-west by the above-described portion of the said new parish of Christ Church, Gateshead, upon the north by the said new parish of Saint Edmund, Gateshead, upon the north-east by the new parish (some-time district chapelry) of Saint Alban, Heworth, in the said county and diocese, and upon the remaining sides, that is to say, upon the south-east and upon the south-west, by an imaginary line commencing upon the boundary which divides the said new parish of Saint Alban, Heworth, from the said parish of Saint John, Gateshead Fell, at the junction of the road leading along the western side of the house and premises called Carr Hill House with Mill-lane, and extending thence south-westward along the middle of Mill-lane for a distance of three chains or thereabouts to its junction with the road called or known as Kimberley-terrace, and extending thence north-westward along the middle of Kimberley-terrace for a distance of seven chains or thereabouts to its junction with Stavordale-road and extending thence westward along the middle of Stavordale-road for a distance of five chains or thereabouts to its junction with Old Durham-road, and extending thence north-westward along the middle of Old Durham-road for a distance of fifty feet or thereabouts to its junction with the proposed street intended to be called Essex-street, and extending thence westward along the middle of the said proposed street for a distance of two chains or thereabouts to the boundary which divides the said parish of Saint John, Gateshead Fell, from the said new parish of Christ Church, Gateshead.

"III. And also all that contiguous portion of the said new parish of Saint Alban, Heworth, which is bounded upon the south-west by the above-described portion of the said parish of Saint John, Gateshead Fell, upon the north-east by the said new parish of Saint Edmund, Gateshead, and upon the remaining sides, that is to say, upon the east and upon the south-east, by an imaginary line commencing upon the boundary which divides the said new parish of Saint Edmund, Gateshead, from the said new parish of Saint Alban, Heworth, at a point in the middle of Split Crow-lane opposite to the middle of the footpath leading from Mount Pleasant to Carr Hill, and extending thence southward to and afterwards first southward then south-westward and then south-eastward along the middle of the last-mentioned footpath for a distance of eighteen chains or thereabouts to the point where it meets the occupation road leading into Carr Hill-road, and extending thence first south-eastward to and then south-westward along the middle of the said occupation road for a distance of one chain and three-quarters or thereabouts to its junction with Carr Hill-road, and extending thence north-westward along the middle of Carr Hill-road for a distance of four chains or thereabouts to its
