

the Council of the borough of Merthyr Tydfil, on the other hand, to enter into and carry into effect an agreement, or agreements, upon such terms and conditions, and for such consideration as may have been or may be agreed upon, for the exchange of lands belonging to them respectively within the borough of Merthyr Tydfil, for the purpose of the erection of a court house, and to authorize the appropriation and user of such lands for that purpose, or such other purposes as may be agreed upon or as may be defined by the Bill, and in particular to sanction the exchange, appropriation and user for purposes other than those for which the lands were acquired, of certain lands acquired by the Council of the borough, or their predecessors, the local Board of Health, under the powers of the Merthyr Tydfil Water Act, 1865, for the erection of a town hall or other public purposes, and certain other lands adjoining or near the police station, Merthyr Tydfil, of which the Glamorgan County Council are the lessees, and so far as may be necessary for the purpose of carrying into effect any such agreement or agreements, and exchange appropriation and user to alter, amend, extend or repeal the provisions of the last mentioned Act, and of any other Act or Acts relating to the borough of Merthyr Tydfil, and the Bill will or may confirm any agreement which may have been entered into touching any of the matters aforesaid.

10. To alter, amend, extend and enlarge, and to incorporate, so far as may be necessary or desirable for carrying into effect the objects and purposes of the Bill, all or some of the powers and provisions of the Merthyr Tydfil Stipendiary Justice Acts, 1843 to 1894; the Stipendiary Magistrates Act, 1863; the Municipal Corporations Act, 1882; the Local Government Act, 1888; and any other Act or Acts (public or private) relating to the County Council of Glamorgan, the borough of Merthyr Tydfil, or to any of the matters aforesaid.

11. To vary or extinguish all powers, authorities, rights, privileges or exemptions inconsistent with the objects of the Bill, and to confer other rights and privileges.

12. The Bill will contain all necessary and proper provisions for carrying the several purposes aforesaid into effect, and will provide for the payment by the Treasurer of the County of Glamorgan out of any moneys received by him for that purpose, or out of any rate authorized to be levied for the purposes of the Acts of 1843 to 1894, and of the Bill of the costs, charges and expenses of and incident to the preparing and passing of the Bill into an Act, or otherwise in relation thereto.

Printed copies of the Bill will be deposited in the Private Bill Office of the House of Commons on or before the 17th day of December next.

WATFORD AND EDGWARE RAILWAY.

(Extension of Time for Compulsory Purchase of Lands and Completion of Works under the Edgware and Hampstead Railway Acts, 1902 and 1905; Altering Section 12 of Edgware

and Hampstead Railway Act, 1905; Extension of Time for Compulsory Purchase of Lands under Watford and Edgware Railway Acts, 1903 and 1906; Diversion of Silk Stream; Agreements with Owners, &c., of Property in Relation thereto; Compulsory Purchase of Lands; Agreements with Edgware and Hampstead Railway Company, Charing Cross, Euston and Hampstead Railway Company and Underground Electric Railways Company of London Limited; Further Provisions as to Capital; Construction and Working of Railways as Light Railways; Incidental Provisions; Incorporation and Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session by the Watford and Edgware Railway Company (hereinafter referred to as "the Company") for leave to bring in a Bill for the following purposes or some of them (that is to say):—

To extend the time limited by the Edgware and Hampstead Railway Act, 1902, and section 12 of the Edgware and Hampstead Railway Act, 1905, for the compulsory purchase of the lands referred to in the said section and also the time limited by the said Act for the completion of the works authorized by the Edgware and Hampstead Railway Act, 1902, and the said Act of 1905.

To extend the time limited by the Watford and Edgware Railway Act, 1903, and section 6 of the Watford and Edgware Railway Act, 1906, for the compulsory purchase of the lands referred to in the said section.

To enable the Company to make and maintain in the parish of Hendon, in the county of Middlesex, an alteration or diversion of the stream known as the "Silk Stream":—

Diversion No. 1, commencing at a point in the said stream at the south-eastern corner of the premises of the Hendon Workhouse, and terminating in the said stream at a point 19 chains, or thereabouts, measured in a south-easterly direction from the point of commencement at the south-eastern corner of the Hendon Workhouse property hereinbefore described.

Diversion No. 2, commencing at the termination of Diversion No. 1 and running in a south-easterly and southerly direction for a distance of 31 chains, or thereabouts, to and terminating in the said stream at a point 7 chains, or thereabouts, eastward of the Edgware-road at or near the southern boundary of the lands belonging to the trustees of the late Sir J. B. Maple.

To authorize the Company on the one hand and the owners of and other parties interested in the said stream or any of them on the other hand to enter into and carry into effect, agreements with respect to the proposed diversion and works connected therewith and the lands required for the purpose thereof, and as to the apportionment of the costs and expenses of the works and otherwise in relation thereto.

To empower the Company to purchase and take compulsorily or by agreement for the purposes of such diversion and works lands and hereditaments.
