## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 7th March, 1907.).

Whereas by the twenty-first section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:

1. And whereas it is expedient, in the interest of public convenience, that Henstead Registration District should be redivided into two Sub-Districts co-extensive with the respective Relief Districts of the Poor Law Union of the same name, to be constituted as follows, viz.:—(a) a Sub-District to be called and known as Humbleyard Sub-District, and to consist of Bracon Ash. Colney, Cringleford, Dunston, East Carleton, Flordon, Great Melton, Hethel, Hethersett, Intwood, Keswick, Ketteringham, Little Melton, Marks-hall, Mulbarton, Newton Flotman, Swainsthorpe, Swardeston, and Wreningham Civil Parishes; and (b) a Sub-District to be called and known as Henstead Sub-District, and to consist of Arninghall, Bixley, Bramerton, Caistor St. Edmund, Framingham Earl, Framingham Pigot, Holverston, Kirby Bedon, Poringland, Rockland St. Mary, Saxlingham Nethergate, Saxlingham Thorpe, Shotesham All Saints, Shotesham St. Mary, Stoke Holy Cross, Surlingham, Trowse with Newton, and Whitlingham Civil Parishes;

2. Now therefore L. Sir William Cospatrick

Now therefore I, Sir William Cospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect

accordingly.

3. This Order shall come into operation on the first day of April, nineteen hundred and seven.
