

sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient that Scarisbrick Sub-District of Ormskirk Registration District should be abolished and its constituent Civil Parishes transferred to other Sub-Districts of the same Registration District as follows:—(a) Burscough Civil Parish, forming part of Lathom and Burscough Urban District, to Lathom Sub-District, which would then include the whole of Lathom and Burscough Urban District, and (b) Scarisbrick Civil Parish to Halsall Sub-District.

2. Now, therefore, I, Sir William Gospatrick Dunbar, Bart., C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on the first day of July, nineteen hundred and seven.
