

seventy-six chains or thereabouts to the centre of the bridge which carries Gunnersbury-lane across the said Ealing Extension line of railway, and extending thence north-eastward along the middle of Gunnersbury-lane (thereby following in part the boundary which divides the new parish of All Saints, South Acton, in the said county and diocese from the said parish of Acton) for a distance of thirty-three chains or thereabouts to its junction with Uxbridge-road and Chatsworth-gardens, and extending thence northward along the middle of Chatsworth-gardens for a distance of sixteen chains or thereabouts to its junction with Buxton-gardens, and extending thence eastward along the middle of Buxton-gardens for a distance of nine chains and a quarter or thereabouts to its junction with Rosemont-road, and extending thence north-westward along the middle of Rosemont-road for a distance of eighteen chains or thereabouts to its junction with Mayfield-road, and extending thence north-eastward along the middle of Mayfield-road for a distance of six chains and a half or thereabouts to its junction with Lynton-road, and extending thence due north in a straight line for a distance of three chains and three-quarters or thereabouts to a point in the middle of the said main line of the Great Western Railway, and extending thence westward along the middle of such line of railway for a distance of thirty-seven chains and three-quarters or thereabouts (thereby crossing the boundary which divides the said parish of Acton from the said new parish of Christ Church, Ealing), to the centre of the bridge which carries the said Ealing Extension line of the Metropolitan District Railway across the said main line of the Great Western Railway upon the boundary which divides the said new parish of Christ Church, Ealing, from the said new parish of Saint Matthew, Ealing Common, at which point the said imaginary line commenced."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.
