Arrête :

Art. 1er. Les dispositions qui font l'objet des articles 1er à 6 de l'arrêté royal du 26 septembre 1907, susvisé, sont rendues applicables aux provenances des provinces de Hollande méridionale et de Zélande, ainsi que dans la partie de la province de Brabant septentrional située à l'Ouest de la ligne de chemin de fer de Baarle-Nassau à Bois-le-Duc (Pays-Bas).

Art. 2. Les provenances, arrivant par mer, seront soumises à la station sanitaire de l'Escaut et dans les ports d'Ostende, de Nieuport et de Zee-Brugge, ainsi qu'à Selzaete, au régime stipulé par le titre 1er, chapitre II, section III, de la Convention adoptée le 3 décembre 1903 par la Conférence sanitaire de Paris.
