ORDER of the Local Government Board: Motor Car Act, 1903: Regulations under Section 9 (1).

COUNTY OF MIDDLESEX.

Urban District of Harrow-on-the-Hill.

To the County Council of Middlesex :-And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas We have received and duly considered an application from the County Council of Middlesex for the issue of a Regulation in pursuance of the said sub-section putting the above mentioned provisions of that sub-section in force within the limits comprising a certain road situate within the urban district of Harrow-on-

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our

Order, make the following Regulations:—
ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising so much of High-street, within the said Urban District, as extends from its junction with Park-road to its junction with Grove Hill and Peterborough Hill.

ARTICLE II .- These Regulations shall come into operation on the twenty-third day of May, one thousand nine hundred and ten.
