

(b) Continuation of Search, per calendar month, 1s.

(c) Fees sent by post may be paid in Bank of England notes, or by banker's draft or postal or post office order, or cheque drawn to the order of the Land Registry or the Registrar or Assistant Registrar.

(d) In cases where, owing to special circumstances, the above fees appear to the Registrar to be insufficient, having regard to the time and labour involved, or likely to be involved, he may decline to undertake the work without such additional payment as he shall think reasonable, and in the reverse case he may, with the previous assent of the Treasury, accept a smaller fee.

## II.

This Order may be cited as the LAND REGISTRY (MIDDLESEX DEEDS) FEE ORDER, 1913, and shall come into operation on the 1st day of March, 1913.

## IRISH LAND ACTS, 1903 AND 1909.

(3 Edw. 7, c. 37, and 9 Edw. 7, c. 42.)
