The Secretary of State for the Home Department hereby gives notice that on the 1st July, 1914, he made an Order under section 33 of the Coal Mines Act, 1911, entitled "The Safety Lamps Order of the 1st July, 1914," approving certain types of safety lamps and flame safety lamp glasses for use in all mines to which the Act applies, subject in each case to the conditions specified in the Schedule to the Order; and making certain amendments in the descriptions of certain lamps and flame safety lamp glasses in the Schedules to the Safety Lamps Orders of the 26th August, 1913, and 16th March, 1914.
