Whereas it is expedient for the sake of clearness to alter the provisions of the Statutes made by the *University Commissioners* for the Queen's College, Oxford, with regard to the duties laid upon the "Senior Fellow" for certain specified purposes:

The College, under and by virtue of the powers conferred upon it by the Universities of Oxford and Cambridge Act, 1877, and of any other power enabling it, at a Stated General Meeting of the Governing Body, held after notice, on the 11th day of November, 1914, unanimously agreed that the following alterations be made in the Clauses of the Statutes made for the College:—

"Wherever in the following clauses, viz.:— in Statt. Tit. 1, Clauses 3 and 7, and in Statt. Tit. XVI, Clauses 1, 3 and 4, the words 'Senior Fellow' are mentioned, these words be deleted and the words 'Senior Official Fellow' be substituted."

Whereas it is expedient to amend the provisions of the College Statutes with regard to the renewal of the tenure of the *Open and Egtesfield Scholarships* now maintained within the College:

The College, under and by virtue of the powers conferred upon it by the Universities of Oxford and Cambridge Act, 1877, and of any other power enabling it, at a Meeting of the Governing Body, specially summoned for the purpose, and after due notice, on the 19th day of June, 1915, unanimously agreed that the following alteration be made in the Clause of the Statutes made for the College:—

In Statt. Tit. III, Cl. 11, after the words "in which case the tenure of his Scholarship shall be renewed for a further term," all the rest of the words in the paragraph shall be deleted and the following words be substituted "of one year. At the end of this period, if the Provost and Fellows shall, by resolution recorded in writing, have declared themselves satisfied with the industry and good conduct of the Scholar, the tenure of his Scholarship shall be renewed for a further term of one year. At the end of this latter period the Provost and Fellows may extend the tenure of any such Scholarship for one year longer, if for special reasons they deem it advisable so to do, but so that the whole term for which the Scholarship is held shall not exceed five years."
