ARMY COUNCIL ORDER. TANNING MATERIALS OR LACTIC ACID.

In pursuance of the powers conferred on them by the Defence of the Realm Regulations, the Army Council hereby require all persons who had in their possession or under their custody or control any stocks of Tanning Materials or Lactic Acid on December 31st, 1915, and/or December 31st, 1916, or imported or exported any such goods between the dates January 1st and December 31st (inclusive), 1916, and all Tanners and other users of Tanning Materials or Lactic Acid, to furnish to the Director of Army Contracts, Imperial House, Tothill Street, S.W., such particulars as may be required on his behalf.
