The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 30th July last, from His Majesty's Minister at Buenos Aires, enclosing the following translation of a resolution issued by the Argentine Minister of Finance on the 17th January:—Until further notice the Custom Houses shall not consider that vessels which have been forced to stop at Kirkwall have touched at an unclean port. Such vessels shall be given entry without the necessity of producing a bill of health, and if they bring a bill of health, the Consular visa on the same shall not be exacted, providing that the vessels have complied with the legal requirements and regulations at the port of sailing, and at the other ports of call during the voyage.
