Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the Insurance Commissioners, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by sub-section 4 of Section 59 of the National Insurance Act, 1911, to make regulations amending Article 27 of the National Health Insurance (Insurance Committees) Consolidated Regulations, 1916, by extending the term of office of the persons referred to in that Article to the 30th day of June, 1918.
