The following Statute made by the University of Oxford, on the 30th day of October, 1917, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of, "The Universities of Oxford and Cambridge Act, 1877."

STATUTE APPROVED BY THE CONVOCATION OF THE UNIVERSITY OF OXFORD, ON TUESDAY, October 30, 1917.

Whereas it is expedient to amend Sectio II. H. § 10 of Titulus IV. of the Statutes of the University of Oxford, so as to vary the constitution of the Board of Electors to the Professorship of Political Economy:

Now the said University, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1877, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:—

1. In Statt. Tit. IV. Sect. II. H. § 10 cl. 4 (p. 132, ed. 1914), the words "nominated on each occasion" shall be struck out, and the word "appointed" shall be substituted; and the words "to act as an Elector on that occasion" shall be struck out.

2. Ibid., cl. 5, after the words "for the time being" the words "or a person appointed by him on the occurrence of a vacancy to act as an Elector on that occasion" shall be inserted; and all the words from "The Regius Professor" to "on that occasion" inclusively shall be struck out, and the following words shall be substituted :—

"(3) A person elected by the Warden and Fellows of All Souls College;

(4) A person elected by the Hebdomadal Council;

(5), (6) Two persons elected by the Board of the Faculty of Modern History, of whom one at least must be a Professor of the University, or of another University;

(7) A person elected by the Board of the Faculty of Literæ Humaniores.

If the Chancellor of the University is unable or unwilling to act as an Elector, his place as an Elector shall be taken by the Vice-Chancellor; except that if an election is to be held at a time when the Warden of All Souls College is Vice-Chancellor, the Hebdomadal Council shall appoint a person to act as an Elector on that occasion in the place of the Vice-Chancellor."
