At the Council Chamber, Whitehall, the 9th day of November, 1917.

By the Lords of His Majesty's Most Honourable Privy Council.

HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act

may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly

Note (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidating List, No. 37A) consolidating all previous Lists was published on the 12th October, 1917, which, together with List No. 38 of 26th October, 1917, and the List herewith annexed, contains all the names which up to this date are included in the Statutory Lisţ

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

†Note (2).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

Note (3).--Trading is prohibited under the Trading with the Enemy Proclamations of 25th June, and 10th November, 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to enquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making enquiries would specify the particular trade or trades for which substitutes are required.

Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

*Note (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy " (Trading Company) or "Naamlooze Venootschap " (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.), as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze." looze.

COURTS (EMERGENCY POWERS) ENGLAND.

THE COURTS (EMERGENCY POWERS) ACT, 1914.

THE COURTS (EMERGENCY POWERS)
ACT, 1917.

Directions, dated eighth of November, 1917, given by the Lord Chancellor under Section 1 of the Courts (Emergency Powers) Act, 1917 (7 and 8 Geo. 5, c. 25), Section 1.

Court to which applications may be made under 7 and 8 Geo. 5, c. 25, s. 1.

- 1. For the purposes of Section 1 of the Courts (Emergency Powers) Act, 1917, the Court to which application is made may be:—
 - (1) in the case of an application to stay proceedings, or an application by way of defence, counterclaim or cross application in any proceedings, the Court in which the proceedings are pending:

(2) in other cases:—

(a) the High Court; or

(b) alternatively, where the subject matter of the contract in respect of which the application is made does not exceed £100, the County Court or the City of London Court.

Subject matter of contract.

2. For the purposes of this direction the subject matter of the contract shall be the price or consideration which, if the contract were or had been carried out, would be or would have become due or payable or receivable under it to or by the party seeking relief.

Rule 2 (4) of Courts (Emergency Powers)
Rules, 1914, to apply.

3. Paragraph 4 of Rule (2) of the Courts (Emergency Powers) Rules, 1914, shall apply to applications under this direction.

Palatinate Courts:

4. Any application which may under this direction be made to the Chancery Division of the High Court may in cases within the jurisdiction of a Palatinate Court be made to that.

Application to County Court, how to be made.

- 5. Any application which may under this direction be made to a County Court or the City of London Court shall be made:—
 - (1) in cases under paragraph (1) subparagraph (1) by summons, defence, counterclaim, or cross summons entitled in the proceedings and "in the matter of the Courts (Emergency Powers) Act, 1917."

(2) in any other case, by summons in accordance with the rules for the time being in force in the County Court as to applica-

tions under paragraph (b) of sub-section 1 of Section 1 of the Courts (Emergency Powers) Act, 1914.

(3) and those rules shall with the necessary modifications, apply to any summons or cross summons under this rule.

AMENDMENT OF ORDER AS TO SUPREME COURT FEES, 1884.

The Right Honourable Robert Bannatyne Lord Finlay, Lord High Chancellor of Great Britain, by and with the advice and consent of the undersigned Judges of the Supreme Court, and with the concurrence of the Lords Commissioners of His Majesty's Treasury, doth hereby in pursuance and execution of the powers conferred by the Supreme Court of Judicature Act, 1885, and all other powers and authorities enabling him in that behalf, Order and Direct in manner following, that is to say:—

1. The following shall be added to Article 69 of the Schedule to the Order as to Supreme

Court Fees, 1884:

"And where the consideration for any property so sold is, in whole or in part, a consideration other than cash, the amount or value of such consideration shall be included in calculating the amount raised for the purpose of determining the fee to be taken."

2. This Order may be cited as the Order as to Supreme Court Fees (Amendment of Article

69), 1917.

On the morning of the 5th February, 1917, a serious explosion, followed by a fire, occurred on

the French troopship "St. Laurent" at Malta.

After some time it was observed that three men in the forepart of the ship, where the flames were fiercest, were cut off from the rest.

None of the boats near would approach the ship owing to the heat and danger of a further explosion, until Acting Quartermaster-Serjeant Brown persuaded a Maltese Policeman to row him out; but when within thirty yards of, the ship the Policeman refused to go further.

Brown returned, and was then joined by Seymour, Allan and Cuthbertson. They rowed directly to the forepart of the ship, the sides of which were by this time red hot, while the plates were falling into the sea.

When they were within a few yards of the ship two of the three men in the forepart jumped into the sea and were rescued; the third, who had climbed up the mast, was saved later-when the mast fell.
