**W**HEREAS by Section 1 of the Burial Act, 1855, it is provided that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in

Council made under any of the Acts recited in the said Act, or under the said Act, as to His Majesty, with such advice as aforesaid, may seem fit:

And whereas His Majesty was pleased, by His Order in Council dated the 20th day of August, 1915, to direct the discontinuance forthwith of burials in the Parish Church of St. Andrew, High Ham, in the County of Somerset, and, with certain exceptions, in the Churchyard attached thereto:

And whereas the time appointed by the said Order in Council for the discontinuance of burials in the said Churchyard has been further postponed by Order in Council from time to time, and now stands postponed, by virtue of an Order in Council dated the 24th day of January, 1917, to the 28th day of February, 1918:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the time for discontinuing burials in the said Churchyard should be further postponed:

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, as it is hereby ordered, that the time appointed for the discontinuance of burials in the Churchyard of the Parish of High Ham, in the County of Somerset, be postponed to the 28th day of February, 1919.

**W**HEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May, 1916, and amended on the 16th day of January, 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom, from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any list of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the said Proclamation of the 23rd day of May, 1916, has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.
