RETURNS AS TO BINDER TWINE.

The Minister of Munitions in exercise of the powers conferred upon him by the Defence of the Realm Regulations and all other powers-thereunto enabling him hereby orders as follows:—

(1) Every person having in his possession or under his control any quantity exceeding ten tons of Standard Binder Twine of an average length of 500 ft. to the pound, and of an average breaking strain of 110 pounds to a length of 8 in., and manufactured before the 30th June, 1917, shall within ten days from the date hereof send to the Director, Imports and Exports Section, Agricultural Machinery Department, Ministry of Munitions, 8, Northumberland Avenue, W.C.2, a return giving full particulars as to quantity and otherwise of such Binder Twine in his possession or under his control.

(2) This Order may be cited as the Binder

Twine (Returns) Order, 1918.
