(3) Sub-Lieutenants, Royal Naval Reserve (Retired), who obtain the necessary qualifications for the Rank of Lieutenant on the Active List to be eligible for the Rank of Lieutenant-Commander 8 years after obtaining such qualifications.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine force to a person being, or having been, an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are, from time to time, directed by Order in Council:

"And whereas it is provided by Order in Council dated the 31st day of December, 1883, that payment shall be made at Royal Marine Divisions, &c., of fees as stated below:—

Fee to Drum Major, to be recovered by stoppage on Pay List from wages of Pupil. For each pupil passing to duty on fife, bugle,

and drum, 21s.

"And whereas we are of the opinion that it is desirable that the payment of such fees should cease, and that the rates of pay of Non-Commissioned Officers, Royal Marines, holding the positions of Drum Major and Bugle Major, and the rates of pay of Buglers, R.M.,

should be revised accordingly:
