#### BRITISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

In the Matter of Ernest Charles Platzer.

Revocation of Certificate of Naturalization.

Whereas I am satisfied that the certificate of naturalization numbered 17570, granted on the 1st September, 1908, to Ernest Charles Platzer was obtained by a false representation made by the said Ernest Charles Platzer to the effect that he intended to reside in His Majesty's Dominions, and also that the said Ernest Charles Platzer has since the date of the grant of the certificate been for a period of not less than 7 years ordinarily resident out of His Majesty's Dominions otherwise than as a representative of a British subject, firm or company carrying on business or an institution established in His Majesty's Dominions or in the Service of the Crown, and has not maintained substantial connection with His Majesty's Dominions, and further that the continuance of the certificate is not conducive to the public good.
