The KING has been pleased, by Warrant under His Majesty's Royal Sign Manual, to appoint Walter Hedley, Esq., Barrister-at-Law, to be Recorder of the Borough of Richmond (Yorkshire).

The Home Secretary hereby gives notice that on the 27th December, 1920, he made an Order under Section 5 (2) of the Employment of Women, Young Persons and Children Act, 1920, appointing the first day of July, 1922, as the date on which the provisions of the said Act relating to night work of young persons shall take effect in Blast Furnaces, Iron Mills, Glass Works and Paper Mills.

The effect of the Order is to permit the night employment of boys between 14 and 16 years of age in Blast Furnaces, Iron Mills, Glass Works and Paper Mills, to continue (subject to the conditions prescribed by the Factory and Workshop Act, 1901) until the 1st July, 1922.
