# BRITTISH NATIONALITY AND STATUS OF ALIENS ACTS, 1914 AND 1918.

### In the Matter of Adolf Schmid.

Revocation of Certificate of Naturalization.

Whereas a certificate of naturalization was granted in the United Kingdom during the present war to Adolf Schmid, who at the date of the grant of the certificate was the subject of a country which was then at war with His Majesty:

And whereas the question whether it is desirable that the certificate should be revoked has been referred to the Certificates of Naturalization (Revocation) Committee constituted under Section 7 of the British Nationality and Status of Aliens Act, 1914, and whereas that question has been answered by the Committee in the affirmative:

Now therefore by this Order made in pursuance of sub-section (1) of Section 3 of the British Nationality and Status of Aliens Act, 1918, I revoke the said certificate, and I direct. such revocation to have effect from the date hereof.

In the Matter of Avedis Mateos Jamgochian.

Revocation of Certificate of Naturalization,
