By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS on 19th August, 1920, the Secretary-General of the League of Nations communicated to His Majesty's Government a certified copy of a draft Convention fixing the minimum age for admission of children to employment at sea which had been adopted by the Labour Conference at Genoa on 9th July, 1920:

And whereas it is provided in Article 405 of the Treaty of Versailles that in the case of a draft Convention so communicated each member of the Labour Organisation shall, if such draft Convention obtains the consent of the authority or authorities within whose competence the matter lies, communicate the formal ratification thereof to the Secretary-General of the League of Nations:

And whereas such draft Convention has in respect of the United Kingdom of Great Britain and Ireland obtained the consent of the authority or authorities within whose competence the matter lies and such action as is necessary to make the provision of the said draft Convention effective therein has been taken:

Now, therefore, the Lords of the Council are pleased to order, and it is hereby ordered, that the said draft Convention be confirmed and approved accordingly and that formal communication thereof be made to the Secretary-General of the League of Nations.

The following Statute made by the University of Cambridge, on the 1st day of July, 1921, has been submitted for the approval of His Majesty in Council, and Notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

STATUTE to alter and amend the Statutes in relation to the University of Cambridge made under the Universities of Oxford and Cambridge Act, 1877, 40 & 41 Vic., Chapter 48, which amending Statute is now submitted for the approval of His Majesty the King in Council.

We, the Chancellor, Masters and Scholars of the University of Cambridge, in pursuance of the power given to us by the 53rd Section of the said Act, do hereby alter and amend the Statutes made under the said Act in relation to our said University in manner following:—

STATUTE A, CHAPTER VI.

*Sermons and Commemorations.*

By repealing in Section 1, intituled "Sermons," the first paragraph (approved by Her late Majesty the Queen in Council on the 13th May, 1896) and substituting therefor the following paragraph:—

"Sermons shall be preached in the University Church every Sunday during full Term as defined by Ordinance and on Ascension Day, and on such other days as may be appointed by the Chancellor or by Grace of the Senate."

#### TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 15th July, 1921, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877; the National Debt Act, 1889, and the War Loan Acts, 1914 to 1919, to the amount of £60,000,000.

2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any date from Monday, the 18th July, to Saturday, 23rd July inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House, or Broker.
